

Accordingly, the comparatives have been adjusted to give the effect of Ind AS 115. The effect on adoption of Ind AS 115 was insignificant on the financial results.
- The figures for the quarter ended June 30, 2021 and March 31, 2021 are balancing figures between the audited figures in respect of the full financial year and the unaudited published year to date figures for the quarter ended June 30, 2020 respectively.
- 5 The financial statements have been prepared on a going concern basis based upon Comfort letter given by the promoters of the Company for any other business to be continued by them in the future.
- 6 The Company doesn't have more than one segment. Therefore, disclosure relating to segments is not applicable and accordingly not made.
